This course is designed to be a Manufacturing Pathway allowing students to enter and exit at multiple points in collaboration with the BRCC Reach Grant.

Proposed MSG

Plan for Recruitment and Selection: Learners will be referred by Local Adult Education Programs and Church World Services a local refugee resettlement agency. CASAS assessment scores will be used to help determine selection.

Shared Learning Objectives, with the College and Career Readiness or English Language Proficiency Standards noted:

Co-Planning and Communication Activities: This IET is a new partnership that includes Blue Ridge Community College (BRCC) and Church World Services (CWS). The initial planning has been completed. The next step is to work on the supportive activities for the BRCC curriculum and



initiate the class. During the front-loaded vocabulary instruction, communication will be led by the Central instructor to keep all partners updated on the progress of the learners. Communication between the instructors during the certification, will occur while both are in the classroom. Other communication will be updates to supervisors and CWS.

Describe how the three components (adult education, workforce preparation, and occupational training) are taught simultaneously and contextually, reinforcing all three types of content through a typical week of the course: The Welding cohort will serve ELLs with Adult Education teaching workforce preparation prior to and during the occupational training. Central will provide front-loaded vocabulary and math support to prepare learners for occupational training. The instructor will also concurrently provide in-class support for the occupational training with scaffolded activities to promote understanding. Workforce preparation is embedded in the curriculum throughout the cohort and BRCC and Central will support the learners' transition from the classroom into employment with one of BRCC's employment partners.

Support Services Provided (indicate agency providing services):

Virginia Career Works (Title I) – funding assistance and continued financial support upon release

Blue Ridge Community College (BRCC) – funding assistance, continued educational opportunities and motivation, job coaching services

Church World Services (CWS) – recruitment, support services (transportation, childcare, etc.)

Shenandoah Initiative for Adult Education (SHINE) – education, motivation, employer contacts, transition to employment, community resources

Employment Placement Activities (indicate agency providing services):

Blue Ridge Community College (BRCC) – has a long-standing list of local employers that are waiting for completers to hire

Employers- Employers provide speakers as part of the classroom experience allowing Human Resources to see the caliber of learners the cohort provides. Partners also provide guaranteed interviews for completers upon release and employment with a successful interview.
